Sub: TNTEU – Affiliated Colleges of Education –II year B.Ed/M.Ed., and II/III/IV year B.Sc.B.Ed,/B.A.,B.Ed, including Special Education Degree Programmes – Commencement of the academic year 2020-2021- Conducting Online Classes-Covid-19 Lockdown period- Guidelines issued - reg.

As per the guidelines of the Higher Education Department, Government of Tamil Nadu, in the recently held meeting, the academic year 2020 – 2021 shall commence from 03.08.2020.

Hence, all the affiliated Colleges of Education are requested to make necessary arrangements for conducting online classes to the students studying in II year B.Ed/M.Ed., and II/III/IV year B.Sc.B.Ed,/B.A.,B.Ed, including Special Education Degree Programmes by following the guidelines given below:

- 1. All Teacher Education Colleges shall commence online classes from 03.08.2020 for students of II year B.Ed/M.Ed., and II/III/IV year B.Sc.,B.Ed,/B.A.,B.Ed, including Special Education Degree Programmes.
- 2. Teachers will conduct classes through online platforms and the teachers are also asked to upload the video lectures along with study materials in the respective College Websites and the quality of the study materials has to be ensured by an Expert Committee duly constituted by the respective Principal of the College of Education.
- 3. The Mobile Number / E-Mail id's and other details of the students should be kept confidential by the faculty members. It should not be disclosed and misused by anyone. It is the complete responsibility of the Principals of the College of Education to make use of the personal information of students for academic purpose only.
- 4. The attendance of students for each online session shall be taken from the online Platforms and the same should be recorded properly by the Principals of the College of Education for future reference.

- 5. As per NCTE Norms, the total working days for B.Ed/M.Ed programme will be 200 days per academic year and for B.Sc.,B.Ed,/B.A.,B.Ed, will be 250 days per academic year, hence the syllabus shall be completed before the end of 200/250 working days including Saturdays.
- 6. The instructions and guidelines for School Internship program for II year B.Ed students and the admission process for I year B.Ed. and M.Ed. degree programmes will be intimated later and information regarding examinations will be sent once guidelines received from the Government.
- 7. Continuous assessment, internal tests, seminars, etc including Practical sessions also be conducted and demonstrated to students through online mode and it should be properly documented for the award of marks.
- 8. The Principals are requested to upload the detailed time table in their College websites
